Articles

In consideration of the fee paid by client and the terms agreed to by client below, Outfitter agrees to follows:

1. The Outfitter will provide equipment, staff, meals, livestock, canvas wall tent and cots with foam pads.
2. The Outfitter is registered with the State of Colorado and will conduct the Pack trip in a professional manner.
3. Trips including Meals will be nourishing and ample, and will be prepared by a competent cook.
4. A guide will be provided for every six clients unless otherwise noted.
5. Horses will be provided and used at the direction of the Outfitter.
6. The Outfitter will be responsible for the conduct of all employees in camp and in the field.

Client Responsibilities

In consideration of the services to be provided by Outfitter, client agrees to bind himself to the following rules and abide by the following rights of the Outfitter.

1. The client will conduct himself / herself as a good sportsman.
2. The Outfitter will be the final authority in the operation of the camp, and at no time will his authority be challenged. Any questions and/or complaints will be taken up directly and in private with the Outfitter.
3. Clients are expected to conduct themselves in a professional manner and not drink to excess.
4. The Client will not mistreat livestock. He will refrain from handling livestock and equipment without the permission from the Outfitter.
5. The Client will observe the advice and recommendations of his guide and will not go out on his own unless approved by his guide and the Outfitter.
6. The Client shall observe all travel and camp rules as verbally set forth by the Outfitter. He will strictly adhere to all Division of Wildlife Regulations.
7. The client upon the signing of this contract will pay one-half of the contracted prices. This amount constitutes a fee to reserve said trip. The balance owed on any trip will be due upon arrival.

8. All monies paid by the client for the trip will be in the form of credit card, cash, money order or check. Payments other than cash will be made payable to Steamboat Lake Outfitters, Inc.
9. The Outfitter will not be responsible for accidents resulting from any violation of safety rules governing firearms, hunting, fishing and livestock.
10. The Outfitter can, at his discretion, change the dates or reduce the number of trip days specified for any of the following reasons; Governmental action, weather or other unpredictable and unusual circumstances, or all clients desiring to terminate trip. The client if unable to abide by these Articles and rules set forth by the Outfitter, will, at the discretion of the Outfitter, be asked to leave the premises as soon as possible. Money paid for the trip will not be refunded.
11. Client will sign liability contracts on arrival at Steamboat Lake Outfitters.
